INTRODUCTION

The AD-14 is an Extension Display for the DL-20 Line. The AD-14 reproduces the exact display from the connected DL-20 unit. Only one AD-14 can be connected to a specific DL-20 unit.

AD-14 AUXILIARY DISPLAY FOR DL-20 LINE

The DL-20 Firmware version **MUST** be V2.06 or higher, or the AD-14 will NOT blank when the DL-20 display goes in Screen Saver mode. The AD-14-7 is a 7" display unit, and the AD-14-10 is a 10" display version. When connected to a DL-20, the AD-14 supplies an exact duplicate of what is displayed on the DL-20s display.








AD-14 INSTALLATION


Make sure that the AD-14 that you are connecting this unit to, has a firmware version of 2.08 or higher. If NOT, update the AD-14 first. All low resolution DL-20 units have the connection in the same format with the S-Video connector to the LEFT. NOTE: Make sure power is OFF when connecting and make sure the Adapter Board is on all 10 pins of the DL-20 board video connector.

















AD-14 MOUNTING








7" DISPLAY MEASUREMENTS

POWER SPECIFICATIONS:

- Input Voltage= Regulated, 12 to 15V DC
